The non-refundable cash payment for each set of tender documents must be paid into the RBIDZ's bank account, namely **Absa, Branch Code: 632005 Account No.: 4072219190 using the contract number as the reference number. No tender documents will be sold less than 30 minutes before starting time of the relevant compulsory briefing meeting.**

Tenders must be completed as set out in the conditions attached to the documents and must be sealed and endorsed with the relevant contract number and must be personally deposited in the official tender box at the RBIDZ, Captains Walk Building, Pioneer Road, Tuzi Gazi Waterfront, Richards Bay **not later than 12h00 on 10 December 2015**, at which time tenders will be opened in public. All queries relating to this tender and documents must be forwarded via email, [tenders@rbidz.co.za](mailto:tenders@rbidz.co.za). Lobbying of officials of the RBIDZ outside of this procedure will lead to disqualification. Tenders will first be evaluated in terms of functionality, and thereafter price and preference on a 90/10 system as contemplated in the Preferential Procurement Policy Framework Act and must score a minimum of **60%** on functionality to be considered further in terms of price and preference. Tenderers who do not obtain the minimum functionality scoring will be regarded as non-responsive that will lead to the disqualification of the Tender Submission.

**NB: Contract No.: 1F/IPD/006/15 (Allumina Alley Road Widening and Installation of Street Lighting for Richards Bay Industrial Development Zone Phase 1F) contains a specific bidding condition that only locally produced or locally manufactured cables with a 90% minimum threshold for local production and content will be considered. Non-compliance with this component will render a tender NON-RESPONSIVE and will it not be considered**
